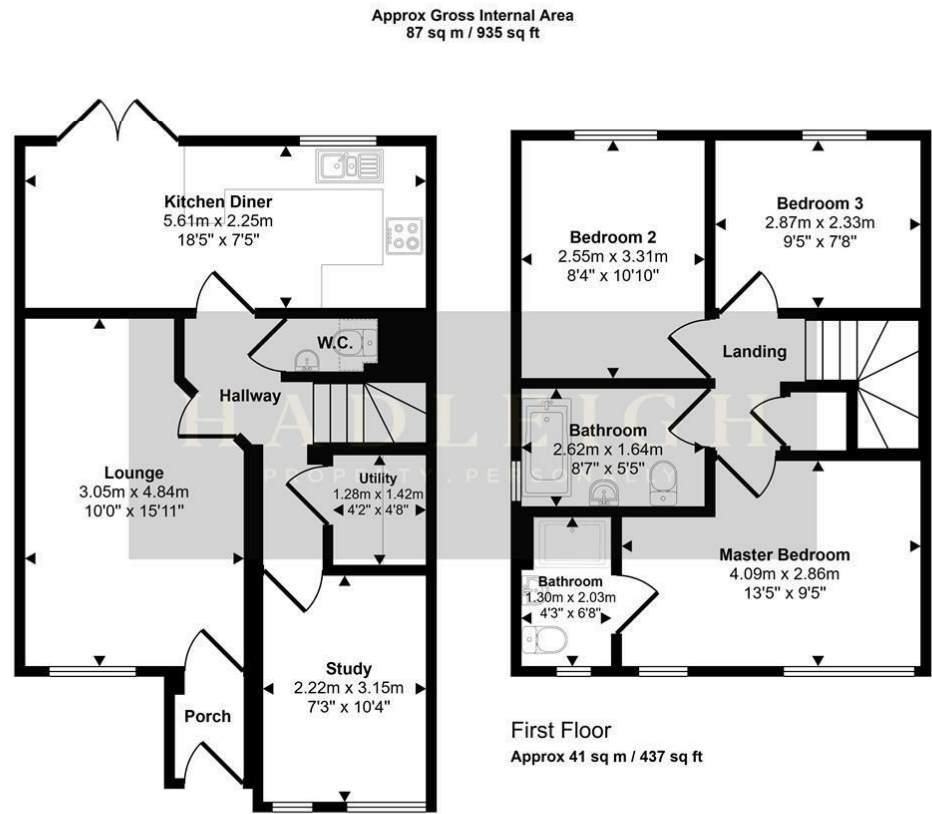

Floor Plan

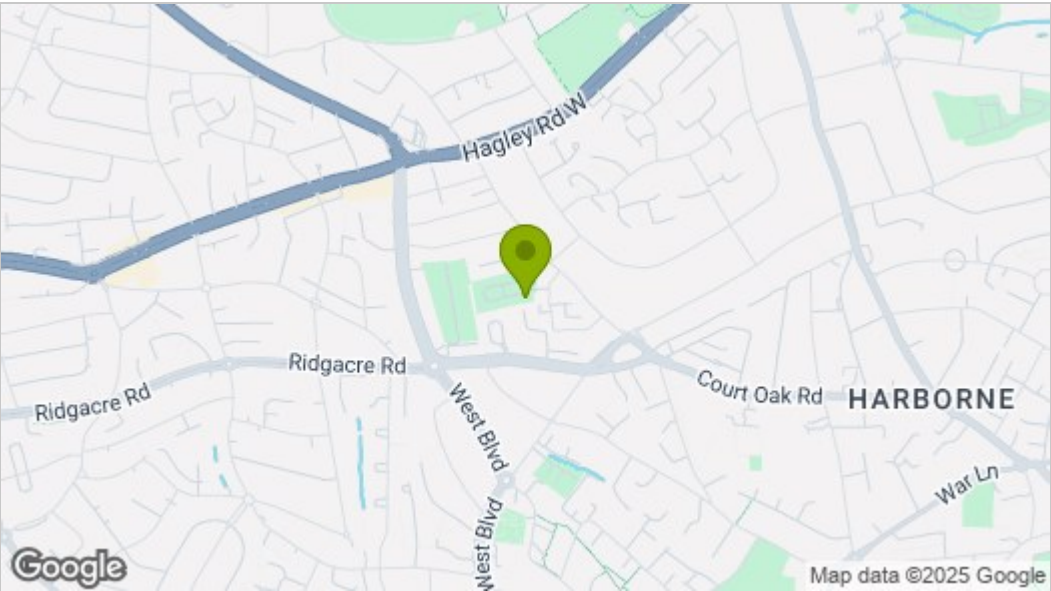


Ground Floor

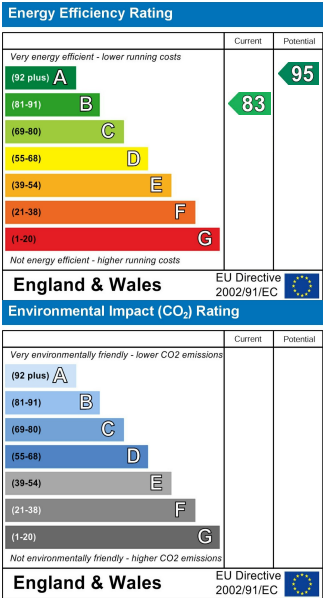
